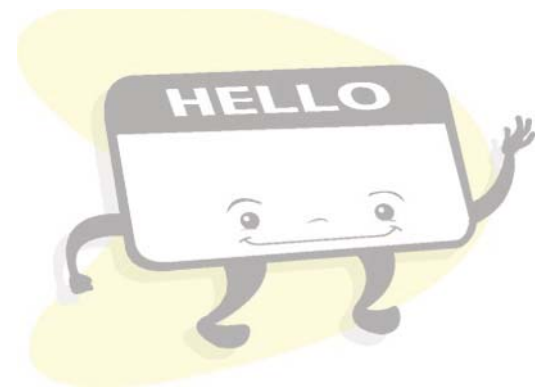
**Program Specialist for Prekindergarten Children with Disabilities**

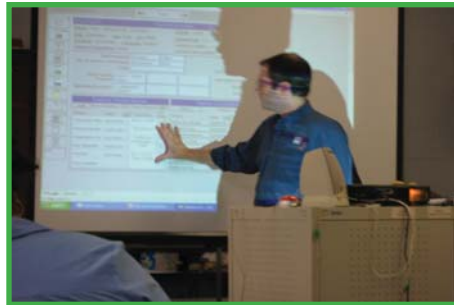

# Early Risk Factors for Developmental Delay and Other Developmental Disabilities

The research study described below was recently published in the journal *Exceptionality*. The complete report can be obtained from the CHRIS web site at [www.chris.miami.edu/Publications/Research.htm](http://www.chris.miami.edu/Publications/Research.htm).

One-third of preschool-aged children with disabilities in Florida are classified with developmental delay (DD). The majority of these children will continue to receive special education services in elementary school. Identification of the factors that place a child at risk for DD may enhance early identification efforts.

For the purposes of the present study, risk factor data from the Florida Department of Health birth

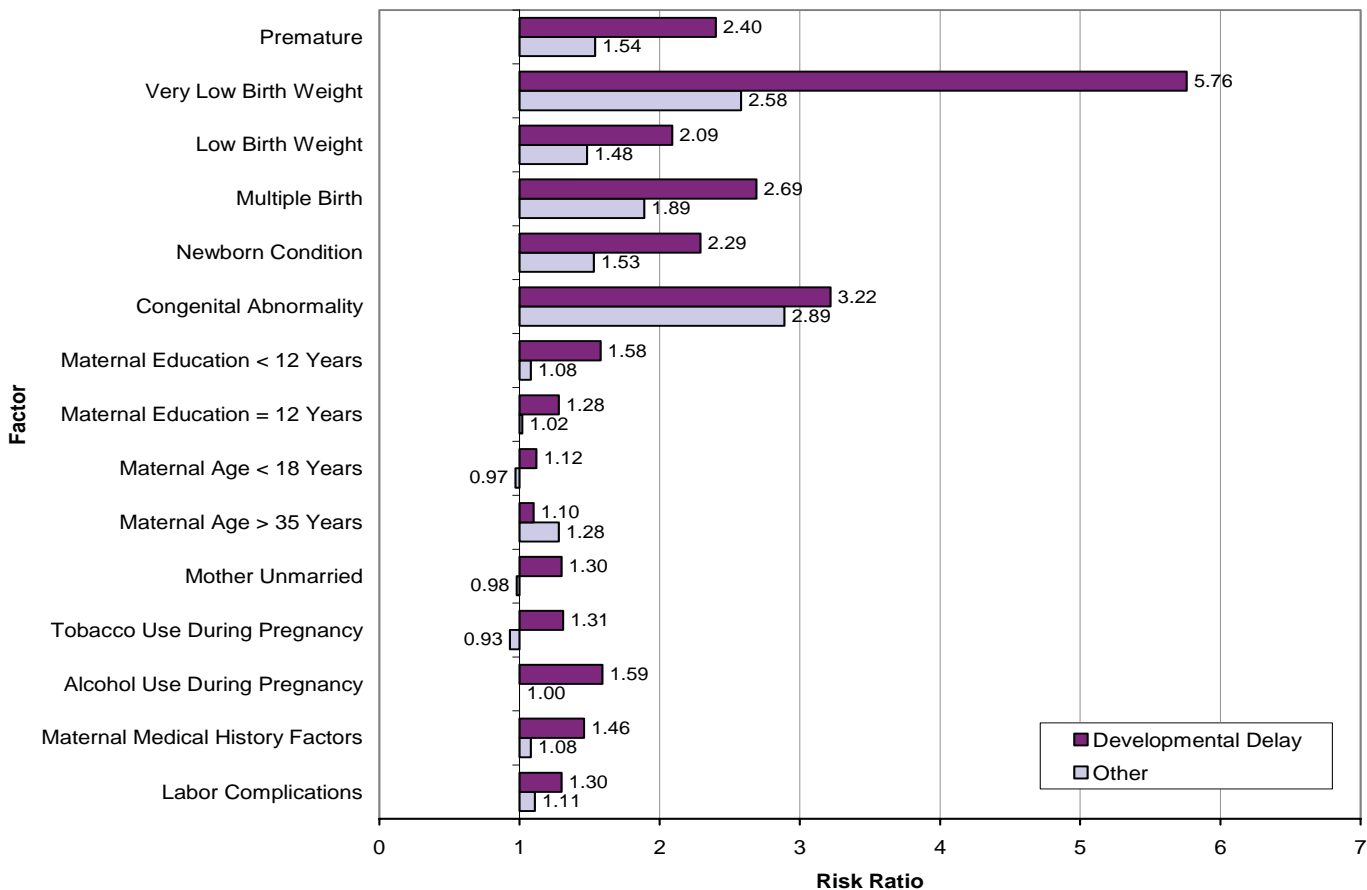
certificate records were integrated with preschool exceptionality data from CHRIS. Risk associated with factors present at birth was compared across the following groups:

- 8,404 children with **DD**
- 9,029 children with speech impairment (**SI**)
- 7,040 children with another disability (**Other**)
- 934,675 children without an identified disability (**No Disability**)

Risk ratios for factors present at birth on rates of DD and Other disabilities are provided in Figure 1 (results for SI can be found in the complete report). The level of risk associated with each factor was determined for each group by

comparing the rate of occurrence of the factor within each group against the No Disability group. A value of 1.0 indicates equal levels of risk for an outcome (e.g., DD) between the groups being compared (e.g., being born at low birth weight versus at normal birth weight). A value less than 1.0 represents decreased risk for an outcome, and a value of greater than 1.0 represents an increased risk.

The results of the study demonstrate that children born with any of a variety of perinatal risk factors, particularly very low birth weight, are at increased risk for being classified as DD and that the risk associated with these factors is greater for DD than for other developmental disabilities.
